Talkeetna Water Filtration (\$1.8M) As of April 12, 2011, DEC has fully approved the plant for operation. A final completion inspection was conducted April 14, 2011, with plant start-up occurring April 19th. The second phase of this project will be installing water meters at all connections to ensure system integrity. This work will occur over the summer of 2011 or 2012 and are currently advertising for engineering services.

Talkeetna Sewer and Water Arsenic treatment plant on line as of Wednesday, April 20, 2011 at 2 p.m. Operating and monitoring.

Talkeetna Library Repairs (\$119K) Exterior paint will occur after window installation and chip sealing will occur over the summer 2011 months.

Trapper Creek Ambulance (\$17K) Casework is under construction for installation week of May 2, 2011.

Trapper Creek Elementary School Roof Repairs (\$110K) Triple V Construction is scheduled to begin work June 2011 and be complete by the end of summer school break.

Bumper Drags Two bumper drags will be held this year, the first bumper drag is April 30th to May 8th, at the Central Landfill from 10 a.m. to 4 p.m., daily. Vehicles, appliances (no refrigerators), and scrap metal will be free of charge.

The second bumper drag will be held in Sunshine at the old Sunshine Transfer Site, located at mile 102.5 of the Parks Hwy, from June 17th to June 25th from 9 a.m. to 7 p.m., daily. For those wishing to clean up private property, one \$10 disposal coupon has been mailed to all developed property owners who reside within the borough to aid in their disposal costs. The coupon will expire May 31, 2012. If someone did not receive their coupon they should call Melisa at 746-2823.

The brush pile will open for free disposal on May 1st at Central Landfill. The Butte, Big Lake, Sutton, Willow, and Talkeetna transfer sites will open their brush pile areas as soon as ground conditions are conducive to vehicle traffic, which will be after May 1st. Current conditions at the transfer sites brush pile areas are quite muddy. It is recommended to call head if you wish to drop off brush to determine if the area is open.
